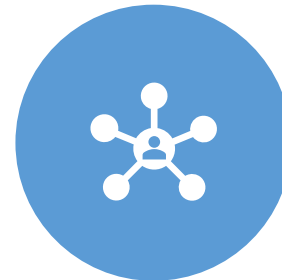

Communities, enterprises and organizations have mandated to implement safety plans, review and update the plans each year, and record and report the plans to local authorities



Organizations are required to submit a safety plan that outlines procedures for emergency situations. As a best practice, safety plans should also incorporate hazards such as widespread flu and pandemic



Many communities, enterprises and organizations lack clear guidance on a safety plan development, accountability systems to document that plans have been completed, and process for assessments or feedback on safety

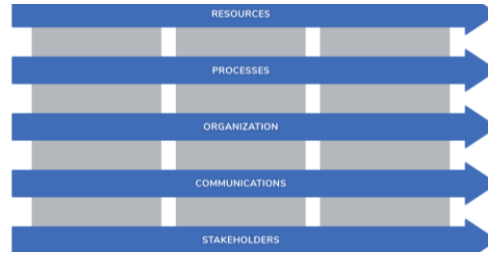
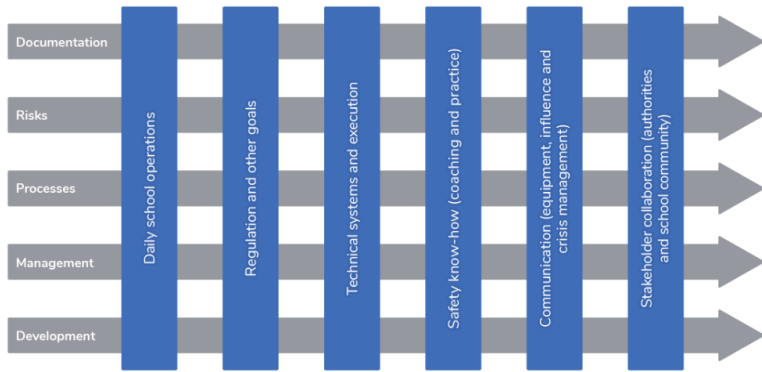
Typical timeline is approximately 8-10 weeks for assessment and then Digital Community Safety Plan implementation

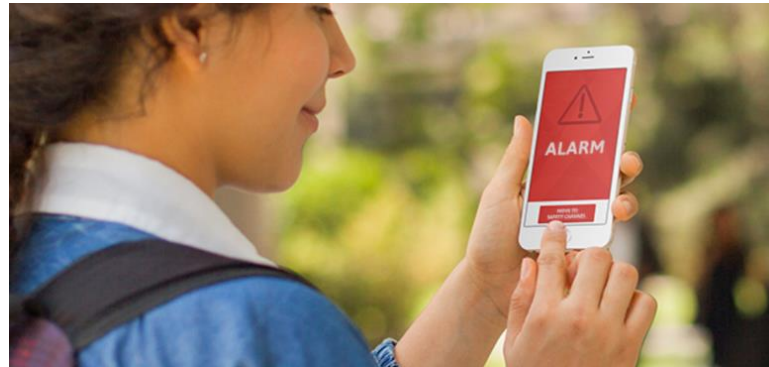

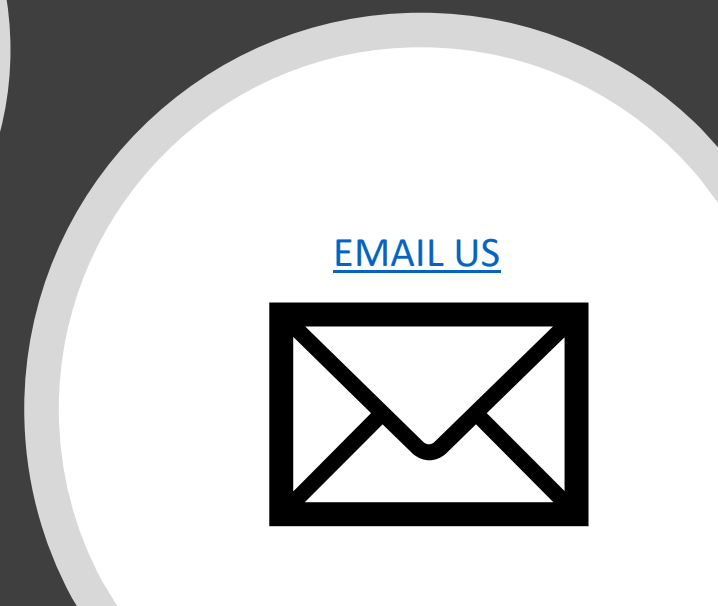
